Our Vision

Over the past several years, digital asset investing has been dominated by long-only, directional strategies—predicated on the assumption that crypto markets would steadily trend upward as adoption grew. While this worked during bull markets, it left investors heavily exposed to volatility, large drawdowns, and prolonged periods of underperformance during downturns.

With 3iQ, we evolved. **We moved beyond simply investing in crypto to investing with crypto—using digital assets not as a bet, but as a medium for executing sophisticated, hedge fund-style strategies.**

The Multi-Factor Strategy is the result of this evolution. **Drawing inspiration from CTA and multi-strategy hedge funds, we've built a long/short approach that uses Bitcoin and Ethereum as trading instruments—not buy-and-hold assets.**

This is not about chasing the next bull run. It's about applying institutional-grade portfolio construction to one of the most liquid and inefficient markets in the world.

Our Investment Approach



Investors are no longer just looking for exposure to crypto—they're seeking smarter, more tactical ways to participate. The demand has shifted from high-conviction directional bets to strategies that can navigate volatility, capitalize on dislocations, and remain resilient across market cycles.

That's where the 3iQ Multi-Factor Strategy comes in.

Instead of trying to predict market direction, our approach dynamically positions long or short in Bitcoin and Ethereum based on real-time signals derived from 10 distinct technical and momentum factors.

Powered by +10 technical factors, the strategy systematically captures both short- and long-term market signals. It rotates between trend-following, mean-reversion, event-driven, and arbitrage sub-strategies to adapt to changing market regimes. The result is a highly flexible portfolio designed to generate consistent, uncorrelated returns—with lower drawdowns and volatility than the underlying crypto assets themselves.

We aim to exploit inefficiencies and extract returns from the structure and behavior of the crypto market itself—using crypto as a trading instrument.

3iQ Criptonite Multi-Factor



The **3iQ Criptonite Multi-Factor Strategy** is a long/short investment approach focused exclusively on Bitcoin and Ethereum.

It combines **two complementary models**:

- BullShark: **A traditional short-term momentum strategy** that captures sharp market breakouts—both up and down—**based on classic momentum indicators**.
- TigerShark: **A dynamic short-term trend-following strategy** that leverages **second derivatives and trend signals** to align with short-term directional moves.

Together, these models analyze over **10 distinct technical factors to systematically identify and capture both rapid breakouts and sustained price movements across market cycles**.

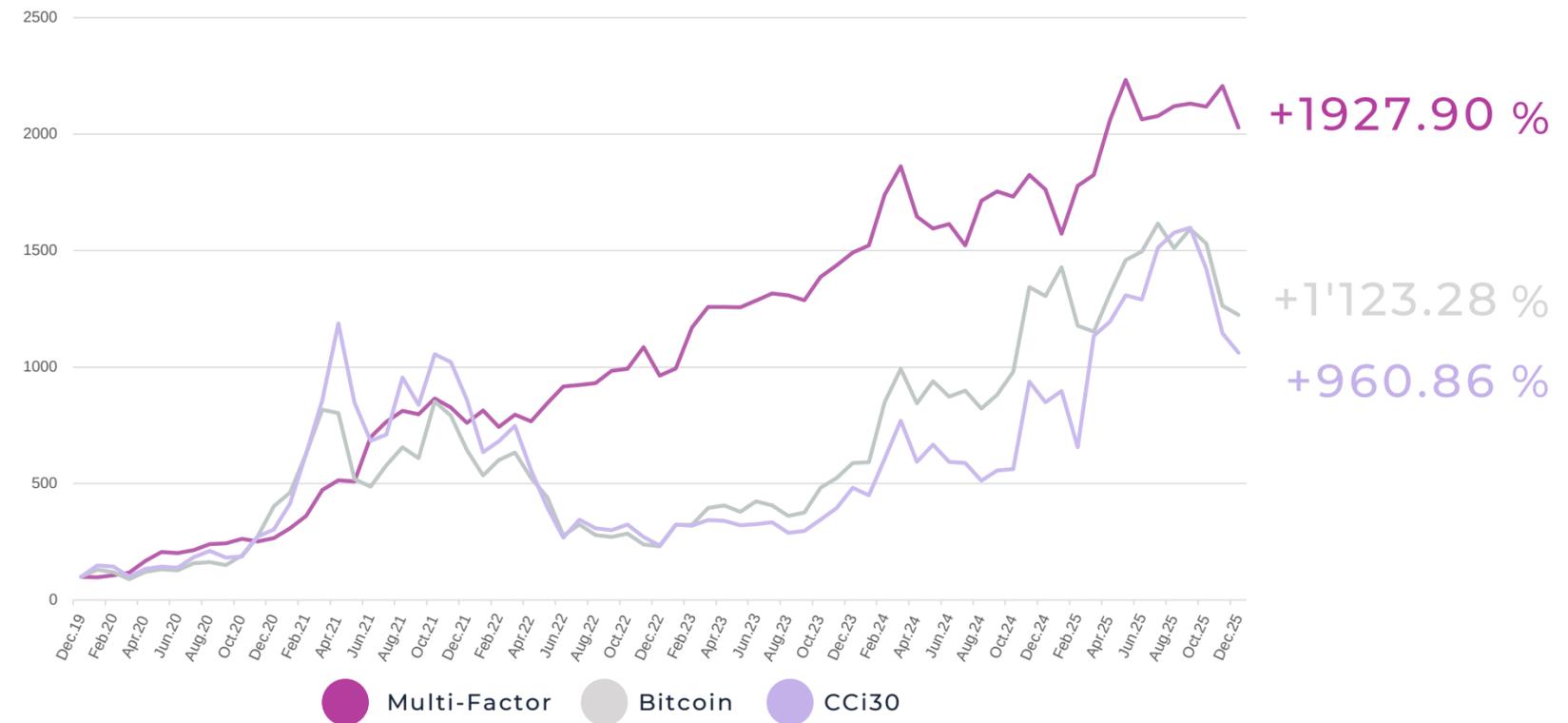

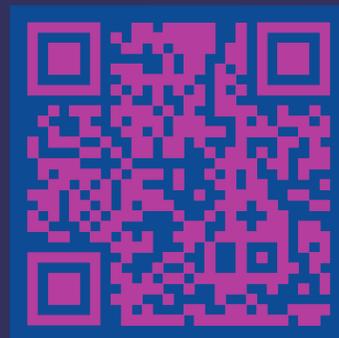
