Achieve Long-Term Growth in a Transformative Market.

The Cryptonite Global Select AMC is the continuity of our Mid-Cap AMC.

We launched the Mid Cap in 2020 to focus on mid-market cap assets. This strategy involved a token selection and market timing approach.

During the bear market and the sharp decline in small alt coins, many Mid Cap investors sought a product with a stronger focus on a buy-and-hold strategy for the bull market phase, exiting only afterward. Others preferred to stick with mid caps (avoiding smaller ones) while continuing to apply a market-timing approach.

In response, we created **Global Select** by separating a group of investors starting in May 2024, gradually investing them in smaller caps.

The Global Select AMC is designed to achieve sustained capital growth by investing in two core areas:

- **Blue Chip Cryptocurrencies:** The top 60 cryptocurrencies by market capitalization, ensuring liquidity and stability.
- **Early-Stage Tokens:** Promising projects at their inception, often not yet listed on mainstream centralized exchanges, capturing outsized growth potential.
